





- Probiotic **gummies** are the fastest-growing probiotic category, growing at a 66% rate YOY, as consumers opt for a format that is easier to consume while offering a unique taste experience.
- Among the top 10 probiotic supplement brands on Amazon today, at least 8 offer probiotic gummies.
- Many of the fastest-emerging supplement brands* are focused exclusively on gummies, and each offers a
 probiotic gummy.
- Growth of spore-forming probiotics is out-pacing growth of conventional vegetative probiotics (16% vs. 9%).
 Spore-forming probiotics are a key enabling technologies that ensures the viability of probiotics in non-traditional applications, including gummy supplements and foods & beverages outside the dairy case.




Sporevia Enables Innovation in On-Trend Applications

- Spore-forming probiotics like Sporevia have a protective, protein-rich outer shell that shields it from harsh conditions, such as the high temperatures of manufacturing and digestive transit.
- This protective shell enables use of probiotics in a wider range of end-use applications like gummies, while also improving survivability to the gut including in conventional applications like capsules.
